

## 2010 NAPABA'S "BEST LAWYERS UNDER 40" AWARD

The purpose of NAPABA's "Best Lawyers Under 40" award is to recognize talented individuals within the Asian Pacific American legal community under the age of 40 who have achieved prominence and distinction in their fields of endeavor—be it the practice of law, academia, business, civic and charitable affairs, the judiciary, or politics—and have demonstrated a strong commitment to APA civic or community affairs.

**Nominees must be APA attorneys admitted to practice in any US jurisdiction and who are under the age of 40 as of October 1, 2010.** Verification of age may be required.

Any NAPABA member or organization may nominate a candidate. The following information must be provided in order for a nomination to be accepted for consideration:

- 1) Fully Completed *Nomination Form* (see attached)
- 2) *Statement in Support of Nominee* (not more than 10 pages)
  - a) *Details* of achievements in the candidate's field of endeavor
  - b) *Details* of candidate's civic and community activities
- 3) Current *CV of Nominee*
- 4) One or more *Letters of Support*
