 - a. An official copy of your most recent law school transcript (or for a first-year law student, a statement from your law school certifying that you are a law degree candidate enrolled at least part-time);
 - b. Resume;
 - c. Two (2) letters of recommendation (from persons not related to you); and
 - d. (Optional) a copy of your application to your law school for financial assistance.
3. If you do not submit the required information, your application will not be considered by the NAPABA Law Foundation.
